



Logical connection between the evidence and facts at issue


Assists in coming to the conclusion – it is "of consequence"

Tends to make a fact more or les probable than it would be without that evidence













Questions Submitted by Complainant

For Respondent

- 1. You knew complainant was too drunk to have sex, but you didn't care, isn't that right?
- 2. In fact, you made sure she was drunk so that you could do whatever you wanted to her?
- 3. Isn't it true that you kept refilling the Complainant's beer because you were trying to get her drunk?
- 4. This is not the first time you have gotten a girl drunk at a party, is it?
- 5. It also isn't the first time that you walked a drunk girl home and then had sex with her while she was passed out?
- 6. You've hooked up with a lot of girls, haven't you?
- 7. This isn't the first time that a girl accused you of rape, is it?
- 8. You have been in trouble with the College before, haven't you?

For Kelsea

- 1. You've had a crush on Caleb for a really long time, isn't that true?
- 2. You are lying for him about how drunk Complainant was that night to get in his good graces, aren't you?

For Maxwell

- When Caleb and Complainant got back to your suite that night, you said you spoke to them for about a minute. Isn't it true that you spoke to Caleb and that Complainant didn't say anything?

- 3. You were with Complainant for most of the night, correct?
- 4. You stated that she wasn't very drunk, isn't that true?
