Application & Food Service Waiver Form

Assumption of Risk, Waiver of Liability, and Indemnity Agreement

The *Leftovers* program is a part of the George Fox University, **Bruin Community Pantry**.

Program Information:

‘Leftovers’ is a program that works to transfer fresh, usable food to students or staff who are looking to supplement their food budget.

On any given day, various departments across campus provide catered snacks or meals for meetings. Due to federal food safety regulations, at the conclusion of the meeting, any leftover food is thrown away.

‘Leftovers’ works with interested departments in reducing the amount of wasted food by packaging up what is usable, in good condition, and immediately bringing it to the Student Life Office to be redistributed to anyone who signs up for this program.

The food will be stored in a safe and appropriate manner until distributed.

Students wishing to participate in this program must sign a waiver and agree to the terms of the program.

Terms and Conditions:

- Students participating in this program must understand there is no guarantee that food will be available on a regular basis
- While every effort will be made to keep this food safe for consumption, students must sign a waiver exempting all participating providers of any liability
- When food becomes available students may pick it up on a first-come-first-served basis
- The amount of food a student is eligible for is based on the number of people in their immediate family

Upon signing this waiver, I agree and understand the following:

1. I hereby release, waive, discharge, and covenant not to sue George Fox University or Bon Appetit, their respective Trustees, officers, employees, students, and agents from liability from any and all claims including negligence of George Fox University or Bon Appetit, their respective Trustees, officers, employees and agents, resulting in personal injury, accident or illness including death and property loss arising from any and all food products provided under the “Bruin Community Pantry,” or the Leftovers program.
2. I agree to indemnify and hold George Fox University and Bon Appetit and their respective Trustees, officers, employees, students and agents from harmless from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney’s fees.
3. I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights including my right to sue. I am signing the agreement freely and voluntarily, and intend by my signature to a complete and unconditional release of all liability as it relates to this agreement to the greatest extent allowed by law.
4. By signing this waiver, I declare that I assume all responsibility for the consumption of food brought to the Leftovers Program by other George Fox University staff.
5. By signing this waiver I acknowledge and agree to the terms and conditions of the Leftover program.
